**Continuing Education Scholarship Application (DUE MARCH 30, 2018)**

The members of the Green County Home and Community Education, Inc. (HCE) organization will award two scholarships, in the amount of \$300.00 each, available to a graduating senior of a Green County High School, a relative of a Green County HCE member or a member of a Green County 4-H Club/FFA or FLCA. The purpose of this scholarship is to encourage individuals to take advantage of continuing education opportunities. Applicants may attend a four-year public or private college or a Technical College either within the state of Wisconsin or outside of the state. The scholarship will be awarded when the applicant has completed two semesters of a four-year college or is at least halfway through their technical college coursework.

  - b. Cover letter telling the voting committee members a little about yourself, your personal goals and objectives, your need for the scholarship and why continuing education is important to you.
  - c. Three reference letters
  - d. Copy of high school transcript

4. Application must be postmarked by March 30, 2018 to be considered. Announcement of the recipient(s) of the scholarship(s) will be made in May 2018.
5. Two applicants will be selected on basis of need, school/community participation, transcripts, references, cover letter and intended use. A personal interview may be required. Selection will be at the discretion of the Scholarship Committee.
6. In order to receive scholarship monies, scholarship recipient(s) will be required to provide (1) a copy of his/her transcripts from the first two semesters of post-secondary education and (2) proof of enrollment for the next semester. Please send this information to the Green County UW-Extension Office. A check will be issued in the name of the recipient in the amount of \$300.00. The Scholarship will be awarded when the applicant has completed two semesters of a four-year college or is at least halfway through their technical college coursework.
